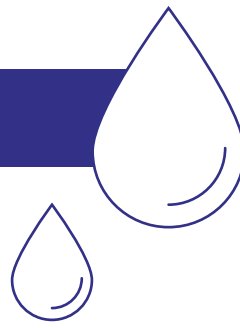

In case he does not have any of the above identifications, he should not be entertained & in such case please inform the service manager regarding the same
2. The contract shall be renewed within time limit of 30 days from the date of expiry of contract only, otherwise the contract shall not be renewed and if renewed, it will be renewed only from the expiry date.
3. The payment for contract shall be made whole in advance, no part payment or payment at the time of completion of contract will be accepted.
4. At the time of making payment of contract, please mention the mode of payment i.e. cheque or cash in your service card along with your signature.
5. In event of any change in your contact details i.e telephone no., please update us with new no. for regular correspondence.
This contract not transferable in case of resale or any gift to other person.
7. Renewal of the service contract after expire will be at the sole discretion of the company, depending upon the condition of the unit.
8. In non working units, contract will not be renewed in any circumstances. In such of the unit will be done at extra cost then and then only the contract will be renewed.
9. Extra charges will be levied for outside city limit visits at extra at actuals.
10. Rs.300/- shall be charged in event of reinstallation of the equipment.
11. The contract shall not cover any damage caused to the equipment from,
 1. Damaged caused to the equipment due to electrical fluctuation, fire, breakage, improper handling or negligence.
 2. Defects due to usage of inferior spare parts.
 3. defects/failures, resulting due to service or repair done but other unauthorized person or representative other than excel product system.
 4. Failure due to civil work of piping's attached to the equipment.
